The Town Clerk enclosed at Appendix "A" a copy of the press statement released by N. Bourne AM which was published in the 12th January, 2001 edition of the Milford Mercury. Copies were also enclosed of two items published in the 19th January, 2001 issue of the paper.

Following the informal meeting convened by the Mayor on the 15th January, 2001, notes of which were submitted to Council, the Council's Insurers, Zurich Municipal had been informed of the press statement and the advice of their Legal Department was requested.

The Town Clerk reported that on the 19th January, 2001 he had been told by the Insurers to contact a Legal Help Line. This matter was fully discussed with a Solicitor, Miss Jill Mantle and based on the given facts her opinion was that the statement was libelous and the Council would be in order to issue it's own press statement to request Mr. Bourne to retract his statement and/or to request the Mercury to retract with the same prominence as the original publication. The Town Clerk informed Zurich Municipal of the legal advice received and was told that they had no objection to the Council taking any of the possible courses of action. It was

This is a voluntary organisation dedicated to supporting older people in Pembrokeshire.

Councillor Mrs. V.M.J. Roach stated that she was the Council's representative on this voluntary organisation who had been successfully obtained benefits and had given advice for some of the local elderly population.

Councillor Mrs. Roach stated that Age Concern have a presence in Pembroke Dock Library on Tuesdays and Wednesdays running the computer help desks, which it is understood that it is intended to provide a worker based probably in the Bush and Park Estates - "People in Communities."

(b) Urdd National Eisteddfod

The 2001 Eisteddfod will be held in Cardiff and the Vale. A financial contribution had been requested.

(c) Relate Dyfed-Powys

This Counselling Service is based at 9 locations across the four counties and in Pembrokeshire Counsellors see Clients at Pembroke Dock and Haverfordwest. The Annual Report and accounts had been received.

(d) Pembroke Dock Museum Trust

The Museum Trust are currently in negotiations with Pembrokeshire County Council and it is anticipated that the Trust will take over the running of the Gun Tower from this coming season. A sum of £1,000 was included in the estimates for 2000/1 and provision for a further £1,000 had been made in 2001/2. On this basis a cheque for £1,000 had been scheduled for approval at this meeting. A balance sheet had been requested and had been received for the information of Members. The general consensus of opinion was that this was the maximum contribution that could be considered by the Council.

Discussion ensued with regard to the formation of the Museum at the Gun Tower and Members who served on the Museum Trust advised that they would be reporting back to Council with further information when available.

RESOLVED -

- That the Council contribute £50.00 to Age Concern Pembrokeshire in order to provide additional facilities for Pembroke Dock.

195. Ferry Lane/Top Road Junction

The Town Clerk enclosed at Appendix "C" copies of a letter received from Mr. N. Ainger MP and of one to him from Pembrokeshire County Council.

Councillor Mrs. V.M.J. Roach stated that whilst Mr. Ainger was awaiting a response from Dyfed-Powys Police regarding records of non personal injury accidents, it was appalling that no consideration was given when prioritising schemes to the general flower of traffic, particularly in the summer period.

198. Regenerating Our Most Disadvantaged Communities

The Town Clerk reported that a second consultation paper had been received from the National Assembly and was available for inspection.

Councillor W.S. Rees submitted that it had been reported that the Youth Centre in Bush Street is to close. He referred to the consultation paper which had documented the deprivation throughout Wales in general and in particular to Llanion Ward in Pembroke Dock which is one of the highest deprived areas in Wales. An infusion of services, finance etc. into the area is required not further dilution of services and facilities.

RESOLVED -

- (1) That Pembrokeshire County Council be advised that the Council oppose the reported closure of the Youth Centre and that no dilution of facilities be considered in view of the above document which highlighted that Llanion Ward, Pembroke Dock was one of the highest deprived areas in Wales. - (2) That the Council would collate objections from organisations in the Town with regard to the proposed closure of the Youth Centre.

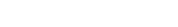

The Mayor welcomed those present and explained that the meeting had been called to discuss various matters which had been identified as key issues for the enhancement of the Town.

(1) Access into the Town from Western Way

The Traffic Manager explained to Members that when Western Way was constructed, one of the grant aid conditions was that there could be no access from it into the Town. If this condition was broken, Pembrokeshire County Council would have to repay £1 million of grant aid. These facts have been checked in the last 18 months.

(2) One way traffic system through the Town

The Traffic Manager stated that the last report concerning a one way traffic flow in Dimond Street was discussed in June, 1999 but had not progressed beyond the Committee stage. If Members wished to consider the matter again he suggested that Pembrokeshire County Council be requested to consider a trial period. However, he urged Members to have the support of local County Councillors and Chamber of Trade etc., before embarking on another scheme.

(3) New signage

The Heritage Lottery Project Officer stated that a Town Trail was proposed within the Heritage Lottery Scheme. There was a possibility that the new signage required by the Council could be incorporated. He suggested that ideas be sent to Pembrokeshire County Council for consideration.

(4) Derelict and untidy areas

The Project Officer informed members that the Pembrokeshire Housing Association were interested in purchasing land at King William Street for a housing development for the disabled. An allocation of funds had been made available. Members welcomed the news.

Regarding the area of land between the St. Govans Centre and the Co-operative Store, the development of this site will be looked at in view of the impending improvements to the Market building under the Heritage Lottery Scheme.

The improvement of derelict property on the corner of Bush Street and Lower Gwyther Street would probably be included in the Town Heritage Scheme.

(5) Memorial Park

The Pembrokeshire County Council Officers had no information regarding improvements to be made in the Memorial Park or the replacement of play equipment.

The Heritage Lottery Project Officer stated that the 20/20 Community Group might be able to access funds under a Victorian Park scheme.

Regarding the provision of a dog free zone, it was thought that with the forthcoming construction of the shared footpath and cycle track to the south of the Park this/could possibly be included in the scheme.

The Mayor thanked Members and the Officers of Pembrokeshire County Council for attending.
