# 1. APOLOGIES FOR ABSENCE

Apologies for absence were received from Councillor R.F. Finbow and S. Perkins.

#### 2. **WEBSTYLE**, 2000

The Mayor welcomed Mr. G. Williams, Webstyle 2000 who had attended the Meeting in order to discuss possible website requirements for the Council.

Detailed discussion ensued when Mr. Williams outlined that if the Council were to proceed in this matter the initial requirement would be to register a domain name which would cost £30 for a two year period. There are only two www. names left which refer to Pembroke Dock and this should be determined immediately. With regard to the design of the website this could be undertaken by Mr. Williams with the Council supplying the appropriate information. The cost being £30 a page.

The Mayor thanked Mr. Williams for providing the Council with detailed information after which he left the Meeting.

# (a) Minute 164 - Western Way - Access Into The Town

# (d) <u>Minute 167(n) - Junction of Cromwell Street/Hawstone Road/</u> <u>Trinity Road</u>

Councillor Mrs. M. Williamson stated that the litter in the above location had still not been removed and it was

# (e) Minute 167(o) - Unauthorised Signs

The Town Clerk reported that a letter had been received from Pembrokeshire County Council which stated that Offiers had removed many of the unauthorised "weight loss" signs from various roundabouts in the area, but unfortunately they had been replaced. The name and address of the responsible persons for erecting the advertisements are being sought.

# (f) Minute 167(p) - Bus Stops - Timetables

Councillor Mrs. C. Fortune enquired as to whether the Council had received the timetables for display in the bus shelters. The Town Clerk stated that he had not yet received the timetables. Councillor Mrs. Fortune stated that she would contact Pembrokeshire County Council direct in this matter.

# (g) Minute 169(227) - Town Awards Scheme

Councillor Mrs. V.M.J. Roach stated that the date in resolution (2) should read 29<sup>th</sup> March, 2001 and not 29<sup>th</sup> April, 2001.

# (h) Minute 169(229) - Purchase of New Photocopier

The Town Clerk stated that the new photocopier would be installed next week and requested Council instruction as to the disposal of the Council's present photocopier. He had been advised that the maximum sale price would be £200.

# RESOLVED -

# (i) Minute 169(231) - Floral Baskets

Councillor Mrs. V.M.J. Roach proposed that Pembrokeshire County Council be requested to give a donation towards the cost of the floral display in the Town, in view of the Council providing additional baskets in Meyrick Street and Queen Street.

The Town Clerk reported that an invitation for the Council to participate in the Wales in Bloom Competition 2001 had been received.

#### RESOLVED -

- That Pembrokeshire County Council be requested to consider giving the Council a donation towards the cost of providing additional baskets for the Town's floral display.
- (2) That Mr. P. Tallett, Chamber of Trade be requested to contact shops, banks etc. with a view to either providing window baskets to enhance the Town's floral display or submit a financial contribution to the Council. It is hoped to enter the Town in the Wales in Bloom Competition next year when the displays would be more established.



# (j) Minute 171(a) – Albion Square Centenary Lamp

Members expressed concern over the continued delay in the work being undertaken to the above Lamp. The Town Clerk stated that he had written to Pembrokeshire County Council regarding the delay and to the fact that they had had the replacement lamps in their possession since July, 2000.

#### RESOLVED -

That Pembrokeshire County Council be requested to advise as to the reason for the continued delay for the repairs to the Centenary Lamp.

# (k) Minute 171(l) - Tregennis Hill - Daffodils

Councillor Mrs. P.E. George stated that she had been told that someone had been seen picking daffodils at the above location and not that she had observed this herself.

### 4. REPORT OF TOWN CLERK

#### 248. One-Way Traffic System

The Town Clerk reported at Appendix "A" the Chamber of Trade's comments in response to the Council's request regarding the introduction of a one-way traffic system in the Town. Of the 70 questionnaires issued by the Chamber, 21 replies had been received to date which were summarised as follows:-

10 suggested a one-way system from Laws Street – Barclays Bank; 9 stated that Dimond Street should be widened or left as it is with access from Lower Meyrick Street;

1 suggested a one-way system from Commercial Row - Laws Street;

1 suggested Dimond Street be pedestrianised.

#### RESOLVED -

That the possible introduction of a one-way traffic system be deferred pending the opening up of the access off Western Way.

# 249. Objective 1 European Funding -- Pater Hall

The Town Clerk reported at Appendix "B" a reply from the PPMB Secretariat, Mr. Gwyn Evans in response to the Council's request for further information regarding the funding allocation for Llanion Ward. An earlier letter was also enclosed which was reported at the last Council Meeting together with the relevant extract from report to Council on the 7<sup>th</sup> September, 2000.

The Town Clerk requested that Members consider the response to be given to item 4 of the letter dated 6<sup>th</sup> March, 2001.

Members referred to the need to upgrade the facilities in Pater Hall which would include lifts, disabled access/toilets.

#### RESOLVED -

That the the Council confirm that funds be made available from the funding allocation for Pembroke Dock Llanion Ward as well as Central Ward in support of the application for the refurbishment/upgrading of Pater Hall.

### 250. Memorial Park, Pembroke Dock

The Town Clerk reported at Appendix "C" the response from Pembrokeshire County Council regarding the Council's recent representations in respect of conditions in the Memorial Park. Also attached was a letter from residents of Gwyther Street which complained regarding the lack of facilities at the Park.

Councillor Mrs. V.M.J. Roach proposed that Pembrokeshire County Council be thanked for the removal of the steps and pump house, and for the replacement of the majority of seats in the Park. That the Council request that a dog litter bin be provided at the top end of the Park away from the toddlers and junior play areas.

Councillor D.L. Jones submitted that dogs should be kept on leads in Park.

#### **RESOLVED -**

- (1) That Pembrokeshire County Council be thanked for the removal of the steps and pump house, and for the replacement of the majority of seats in the Park.
- (2) That Pembrokeshire County Council be requested to provide a dog litter bin at the top end of the Park, away from the toddlers and junior play areas.
