The Mayor thanked Commander Mason on behalf of the Council for the plaque to commemorate the Ship's visit to the Town which would be displayed in the Council Chamber.

#### 90. Objective 1 European Funding - Pater Hall

The Town Clerk reported that since the last Council Meeting he had undertaken considerable research and fact finding prior to the submission of the application for Objective I funding for upgrading the Pater Hall complex.

He had had a very informative meeting with the European Officer, Mr. Gwyn Evans, on the 7<sup>th</sup> August, 2000. According to the Objective 1 programme compliment an application from the Council would come under either:-

PRIORITY 3
RATE

<u>GRANT</u>

Regeneration of Deprived Areas through Community-led action

68.09%

OR

**PRIORITY 5** 

Rural Development - promoting Local Economic Development

41.92%



The geographical areas which would come under the "Deprived Area" status had not yet been determined and discussions were on-going. There is also great concern at the way the targeting formula had been calculated and the European Officer had written a strong letter of protest to the Welsh Assembly.

#### The Application Process

Applications for Objective 1 funding are generally made through "Action Plans" which are being devised by Partnerships established specifically for this purpose. There are three stages in the application process:-

- (a) Initial applications are considered and appraised by the Pembrokeshire Partnership Management Board. After appraisal they are considered by a meeting of the full partnership and endorsed or rejected.
- (b) Endorsed projects are included in the Local Action Plan in outline only.
- (c) A full application form is required following approval of the Action Plan and its constituent projects by the Welsh European Funding Officer.

The Town Clerk advised that since his meeting with the European Officer, the initial application form and copious supporting information had become available on the Internet and Mr. Henry Johnston of the Pembrokeshire Business Club very kindly downloaded them for the Council's information. Hard copies had now been received from Mr. Gwyn Evans. Applications had to be submitted to the Partnership by the 15<sup>th</sup> September, 2000 and endorsed projects would be included in the Pembrokeshire Local Plan for submission to the Welsh European Funding Office on the 29<sup>th</sup> September, 2000.

# Other Possible Funding

This matter had been discussed with Mr. K. Wakefield, Head of Economic Development, Pembrokeshire County Council. The Rural Development Scheme under which the Pembrokeshire County Council have previously provided funding to the Authority has now ceased. It had been replaced by a Local Regeneration Fund and an application for funding from this source might be possible. However, full details of the arrangements would not be known until October. Enquiries regarding other possible match funding are ongoing.

#### Basis of the Application

For Members' information, budget costings for the previous grant application to the Arts Council for Wales were detailed below. This matter had been discussed with Mr. G. Scourfield of Pembroke Design, the inflation element since they were prepared in 1998 and he suggested, following consultation with a Quantity Surveyor, a 10% increase across the board.

The previous budget costs included cinema equipment (£60K) and seating (£12K). Also a new boiler was included in the costs of upgrading services. The Council purchased a new new boiler in 1998 at a cost f3,295. If the cost of the new boiler together with the cinema and seating costs were deleted from this application the shortfall would be reduced to:-

In the 1998 application, Council had agreed to allocate £50,000 from reserves towards the project.

#### Deadline for Application

As Members are aware, the timetable for submission of this application is tight, with the initial application form due in by the 15<sup>th</sup> September, 2000.

Mr. Henry Johnston of the Pembrokeshire Business Club, who is very much involved with the new Objective 1 legislation had already been most helpful and had agreed to provide assistance with the application process should it be needed.

The Town Clerk stated that Members instructions on whether the application should proceed with the same specification as in 1998 or whether any revisions are to be included were necessary.

#### RESOLVED -

The Town Clerk reported that following the last Council Meeting he had sent a Recorded Delivery letter to the proprietor, Mr. R.P. Morgan on the 2<sup>nd</sup> August, 2000. No response had been received. Two further telephone calls were made on the 10<sup>th</sup> and 15<sup>th</sup> August, 2000 with urgent requests for either Mr. Morgan or Mr. Floyd to return the call. No response had been received. In order to clarify the legal position, this matter had been discussed with a Senior Member of the Pembrokeshire County Council's Legal Department who had suggested that a further Recorded Delivery letter be sent advising that legal advice on further action would be taken within seven days. This action had been taken but no response had been received.

The Town Clerk stated that he had discussed this matter with Mr. Alan Thomas with a view to a possible tender from him for the completion of the required work. Mr. Thomas had agreed to undertake any alterations required by the Council.

For Members' information a part payment of £1,500 had been made in respect of the invoice for £3,043.25 (inc. £453.25 VAT).

#### RESOLVED -

#### PART II - GENERAL

# 90. OBJECTIVE 1 EUROPEAN FUNDING – PATER HALL

Since the last Council Meeting I have been doing considerable research and fact finding prior to the submission of the application for Objective 1 funding for upgrading the Pater Hall complex.

I had a very informative meeting with the European Officer, Mr. Gwyn Evans, on the 7<sup>th</sup> August, 2000. According to the Objective 1 programme compliment an application from the Council would come under either:-

PRIORITY 3 GRANT RATE

Regeneration of Deprived Areas through Community-led action

68.09%

OR.

#### PRIORITY 5

Rural Development - promoting Local Economic Development

41.92%

The geographical areas which will come under the "Deprived Area" status have not yet been determined and discussions are on-going. There is also great concern at the way the targeting formula has been calculated and the European Officer has written a strong letter of protest to the Welsh Assembly.

#### The Application Process

Applications for Objective 1 funding are generally made through "Action Plans" which are being devised by Partnerships established specifically for this purpose. There are three stages in the application process:-

- (a) Initial applications are considered and appraised by the Pembrokeshire Partnership Management Board. After appraisal they are considered by a meeting of the full partnership and endorsed or rejected.
- (b) Endorsed projects are included in the Local Action Plan in outline only.
- (c) A full application form is required following approval of the Action Plan and its constituent projects by the Welsh European Funding Officer.

Since my meeting with the European Officer, the initial application form and copious supporting information became available on the Internet and Mr. Henry Johnston of the Pembrokeshire Business Club very kindly downloaded them for me. I have since received hard copies from Mr. Gwyn Evans. Applications have to be submitted to the Partnership by the 15<sup>th</sup> September, 2000 and endorsed projects will be included in the Pembrokeshire Local Plan for submission to the Welsh European Funding Office on the 29<sup>th</sup> September, 2000.

#### Other Possible Funding

I have discussed this mater with Mr. K. Wakefield, Head of Economic Development, Pembrokeshire County Council. The Rural Development Scheme under which the Pembrokeshire County Council have previously provided funding to the Authority has now ceased. It has been replaced by a Local Regeneration Fund and an application for funding from this source might be possible. However, full details of the arrangements will not be known until October. My enquiries regarding other possible match funding are ongoing.

#### **Basis of the Application**

For Members' information, budget costings for the previous grant application to the Arts Council for Wales are detailed below. I have discussed with Mr. G. Scourfield of Pembroke Design, the inflation element since they were prepared in 1998 and he suggested, following consultation with a Quantity Surveyor, a 10% increase across the board.

Mr. Henry Johnston of the Pembrokeshire Business Club, who is very much involved with the new Objective 1 legislation has already been most helpful and has agreed to provide assistance with the application process should it be needed.

Following the last Council Meeting I sent a Recorded Delivery letter to the proprietor, Mr. R.P. Morgan on the 2<sup>nd</sup> August, 2000. No response was received. I regret to report that this has again brought no response.

I shall now contact Mr. Alan Thomas and discuss a possible tender from him for the completion of the required work and will report further at the meeting.



It comprises National Cycle Network Routes 4 and 47 in a braid and these routes, now substantially complete, were officially opened on June 21 as part of the Longest Ride cefebrations nationally. In all some 10 000 miles of the national network, existing and proposed, were cycled on that day and some 5000 miles of completed route were opened. There were over 450 official receptions along the way at in key locations and over 1500 events were staged. We are very grateful to all who helped or took part in his massive trailblazing effort to make it such a success. Such has been the success of the National Cycle Network, and initiatives advocated in parallel (such as Safe Routes to Schools, links to Bus and Rail Stations, 'Employer ravel Plans', 'Home Zones' and 'Integrated Travel Centres') that accord with the sustainable Transport and Health Policies promoted by the National Assembly for Wales, that these initiatives in Wales are to be further developed and SUSTRANS with support from the NafW and in partnership with local authorities and other agencies will have a coordinating role in this development. As a consequence SUSTRANS is to set up a Wales administration to coordinate this effort and details will be announced The acclaimed maps of the Celtic Trail/Lôn Geltaidd for both West and East sections great interest is being shown by tourists already. Next year, as marketing of the route have been published (over 2300 have been sold internationally since mid-June) and develops, even greater interest is anticipated. Cycle Tourism in Wales is being

increasingly promoted by the Wales Tourist Board and marketing initiatives are being developed and accommodation providers, cafes, pubs and attractions along the way are set to benefit.

While the national routes are strategic, they provide on a local level safe connection for many communities along the way, and where off road have proved to be very important local transport and recreational facilities for cycling and walking, especially for the young, the old and physically impaired. We hope that your local community groups and commerce can be involved in further route development to suit the particular needs of your area, and SUSTRANS will be pleased to assist in this respect. Many other aspects are being considered including rest areas, sculpture, nature trails and importantly, new ways of achieving proper maintenance and encouraging local ownership. If you would like to discuss ways in which the development of the Network could benefit your Community please contact me at the above address.

To assist local tourism we are also seeking Heritage Lottery funding to develop a major Interpretation Project which will work with local interests and communities in identifying the built and natural heritage along and adjacent to the Trail.. We would very much value advice and assistance in making your part of the Lôn Geltaidd / Celtic Trail project a success. We are also preparing a leaflet describing the route and would like to discuss and update its development with you.

Our first priority is to complete the identified Network across South Wales and the consortium has prepared a bid for funding through Objective 1 combining the western and eastern sections of Lôn Geltaidd / Celtic Trail. We are seeking the support of communities across the region in this application and should be most grateful if your council would write a letter of support to the coordinating authority:
