The Meeting was opened with Prayer.

**154. APOLOGIES FOR ABSENCE**

Apologies for absence were received from Councillors W.J. Davies and D.L. Jones.

**155. COUNCILLOR W.J. DAVIES – INDISPOSITION**

The Town Clerk reported that Councillor W.J. Davies had sustained a fall which resulted in a possible fracture to his arm.

**RESOLVED –**

That a get well card be sent to Councillor W.J. Davies wishing him a complete recovery from his indisposition.

**157. MATTERS ARISING FROM THE MINUTES**

**(a) Minute 145(d) – Llanion Park – Artefacts**

The Town Clerk stated that the plaques had been officially handed over to this Council on the 7<sup>th</sup> February, 2001 and would be displayed in the Council Chamber.

(b) **Minute 145(f) – Pembrokeshire County Council – Free Contact Number**

Councillor Mrs. V.M.J. Roach stated that there was one (6) too many in the free contact number for housing repairs which should be amended to read 08000 856622.

(c) **Minute 149(193) – Press Statement by Nick Bourne A.M.**

Councillor Mrs. V.M.J. Roach stated that Councillor Owen had proposed that no further action be taken in this matter and that she had seconded the proposal. It was agreed that the Minute be amended accordingly.

(d) **Minute 149(194(c)) – Relate – Dyfed-Powys**

The Town Clerk reported that he had been advised that consultations are held in the Pembroke Dock Health Centre each Wednesday.

Councillor Mrs. P.E. George stated that she had received representations from Youth Centre users who will be submitting Petitions against the proposed closure of the Centre.

(g) **Minute 149(202) – Planning Application No. 27/LB**

Councillor Mrs. V.M.J. Roach stated that the words "brass sign" had been omitted in respect of the above application. It was agreed that the Minute be amended accordingly.

(h) **Minute 151 – Access Awards**

The Mayor stated that the Competition Awards ceremony held on the 9<sup>th</sup> February, 2001 had been well attended and very successful.

(i) **Minute 153(b) – CCTV Cameras – Pembroke Dock**

Councillor Mrs. V.M.J. Roach stated that she had contacted Acting Inspector Russell Smith regarding availability of dates to view the new CCTV cameras in Pembroke Dock Station and attendance at incidents.

(j) **Minute 153(c) – Pembroke Borough Silver Band – Conductor**

Councillor Mrs. V.M.J. Roach expressed her appreciation to the Town Clerk for requesting the Western Telegraph to publish a news item regarding the above which had appeared in the 14<sup>th</sup> February's edition.

(k) **Minute 153(e) – Birdcage Walk - Railtrack**

Councillor Mrs. P.E. George stated that new railings had been erected at the above location. whilst Councillor P.G. Gwyther referred to the litter in that area which it was hoped would be cleared.

(a) **Access into the Town from Western Way**

The Traffic Manager had explained that when Western Way was constructed one of the grant aid conditions was that there could be no access from it into the Town. If the condition was broken, Pembrokeshire County Council would have to repay £1 million of grant aid.

Reference was made to the fact that grant aid had been given for industrial use at the Bierspool site, this condition was broken and retail units were permitted at this location.

(b) **One way traffic system through the Town**

Discussion ensued regarding the possibility of a one way traffic flow in Dimond Street.

**RESOLVED –**

That the views of the local County Councillors and Chamber of Trade be sought on the possible introduction of a one way traffic flow in Dimond Street for a trial period, from Pater Hall to Barclays Bank junction.

(c) **New Signage**

The Heritage Lottery Project Officer had stated that a Town Trail was proposed within the Heritage Lottery Scheme. There was a possibility of new signage which could be incorporated

**RESOLVED –**

That Pembrokeshire County Council be requested to provide signage to incorporate all places of interest, facilities etc. within the Town in the Gordon Street/Leo's car park.

(d) **Derelict and untidy areas**

The Project Officer advised that the Pembrokeshire Housing association were interested in purchasing land at King William Street for a housing development for the disabled. Funding had been allocated. Members welcomed the news.

The development of the area of land between St. Govans Centre and the Co-operative Store, will be looked at in view of the impending improvements to the Market building under the Heritage Lottery Scheme. The improvement of derelict property on the corner of Bush Street and Lower Gwyther Street would probably be included in the Town Heritage Scheme.

**RESOLVED –**

That the above items be deferred for further consideration at the next Network Meeting to be held in June, 2001.

(e) **Memorial Park**

No information was available regarding improvements to be made in the Memorial Park or the replacement of play equipment.

Regarding the provision of a dog free zone, the forthcoming construction of the shared footpath and cycle track to the south of the Park could possibly be included in the scheme.

**208. The Firework Company**

In accordance with the contract, 50% was paid by 30th November, 2000 with the remainder due for payment by the 10<sup>th</sup> December, 2000. Payment being made from the Tourism Account.

The Town Clerk reported that following the incident at the display the second instalment was not paid by the 10<sup>th</sup> December, 2000 and a reminder had been received which requested that payment in accordance with the terms of the contract be made.

The Town Clerk advised that an Inspector from the Council's Insurers, Zurich Municipal had visited the Offices and met with the Mayor, Chairman of the Tourism Committee, Councillor Mrs. P.E. George and the Secretary to discuss the above incident. A written witness statement was signed by him for Zurich Municipal.

Discussion ensued at the meeting regarding payment of the second instalment and it was submitted that the Council could withhold payment if they so desired until the result of the inquiry had been received.

The appeal is to be decided on the basis of an exchange of written statements by the parties and a site visit by an Inspector. Any comments already submitted following the original application for planning permission may be subject to public disclosure and forwarded to the Planning Inspector and will be taken into account by the Inspector deciding the appeal. In the event of these comments being either withdrawn or modified these should be submitted in writing direct to the Planning Inspectorate.

Members were reminded that this planning application was considered at the Council Meeting held on the 7<sup>th</sup> September, 2000 and Council resolved that the application be refused since the proposed development would interfere with a public right of way.

That Pembrokeshire County Council be requested to undertake clearance of the wet ground at the above location as well as to trim back undergrowth.

That timetables be provided for the above bus stops.

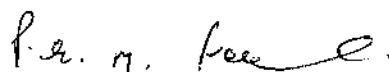
(h) **The Mount/Laws Street – Footpath – Seat**
