#### 6. REPORT OF TOWN CLERK

#### Town Twinning with Pembroke, Malta 1.

The Town Clerk stated that as discussed at the last meeting, the Mayor and Deputy Mayor had met the Mayor and Deputy Mayor of Pembroke to discuss a way forward. The Mayor stated that the conclusions reached at the meeting was to disband the Joint Tourism Committee and that a new Joint Twinning Committee be formed to be known as Pembroke Dock & Pembroke Joint Twinning Committee.

Reproduced at Appendix "A" was a letter from the Mayor of Pembroke, Malta together with a copy of his letter to Pembroke Town Council on the 5<sup>th</sup> March, 2002. A delegation from Malta is planned to visit Pembroke Dock and Pembroke between 30th April - 7th May, 2002. If a commemorative plaque was to be unveiled, it would be necessary for Members to discuss the type and location so that the necessary arrangement could be made.

The Town Clerk referred to the proposed visit by a group of 45 children and officials in July, 2002. EU grant application forms had been submitted to the Town Twinning Department in Brussels. As no decision would be known for some weeks, a copy had been sent to the local M.E.P's office in Cardiff with a request for assistance to ensure that a decision would be reached as soon as possible.

The Town Clerk stated that he had received a telephone call from Malta earlier in the day regarding the cost of the flights which were very expensive and enquired as to whether financial assistance could be given. No decision could be made on this matter until the outcome of the grant application was known.
