121. VISIT OF REPRESENTATIVES OF DYFED-POWYS POLICE

The Mayor welcomed Inspector I. Matthews and P.C. M. Bevan, Dyfed-Powys Police to the meeting to discuss policing of the Town. Reference was made to the success of the CCTV cameras and video footage of a crime was shown which had secured arrests and had been submitted as evidence in Court and resulted in a prison sentence.

Discussion ensued with regard to the anti-social behaviour of some youths in the Town which was being redressed. Traffic congestion was discussed in some detail in particular in Dimond Street.

P.C. Bevan referred to the Dyfed-Powys Crime Prevention Trust Bobby Van Scheme which provided a free home security service for the elderly which had reduced repeat victimisation and burglary. All local councils would be requested to make a donation towards this scheme to guarantee that all running costs are met for this year.

The Mayor thanked Inspector Matthews and P.C. Bevan for their attendance at the Meeting and presented each with a Council tie.

Thank you for taking the time to meet with Carolyn Williams of WEFO, Alex Allison of the County Council's Community Regeneration Unit and myself on 24 October to discuss this application.

As we discussed, there are a number of difficult issues concerning the application that need to be resolved before the application can be progressed. These are:

- Public administration buildings are ineligible for ERDF funding. Consequently
 any aspect of the refurbishment/upgrading that relates to the use of the building
 by Pembroke Dock Town Council would not be able to receive Objective 1
 support. This may involve apportioning the capital costs on the basis of floor
 area.
- 2. It is accepted that the whole community of Pembroke Dock uses the Pater Hall. However, Priority 3 only applies to two wards, namely Central and Llanion. As a consequence of the need to comply with the Priority 3 targeting rules the level of Priority 3 funding available to this project would have to reflect the actual or likely residence of people using the Pater Hall. The project would also have to demonstrate that the beneficiaries from the targeted wards form the majority of those using the Hall.
- 3. From the previous point, we would want to know how many of the outcomes of the project relate to individuals or groups from the two targeted wards.
- There are no Results given for the project (e.g. community-led projects supported or gross jobs created). This raises issues about value for money.
- 5. Further evidence is needed to demonstrate that the project delivers the aims and objectives of Objective 1 as set out in the Single Programming Document and the Programme Complement.
- We would like to see detail of the activities that would be undertaken at the Pater Hall to be assured that they are eligible under priority 3 Measure 3.
- 7. Priority 3 Measure 3 projects must be managed by a voluntary or community organisation from the community concerned (in this case, Pembroke Dock Central) or that the project is managed by a partnership in which the representatives from the community involved are in a majority. Neither condition

seems to be fulfilled in this case. We understand that consideration has been given to establishing a Pater Hall Trust to run the hall. Whilst this would help overcome this problem we would not recommend establishing a Trust to secure Objective 1 funding unless the remainder of the issues surrounding this application can be resolved.

- 8. The application mentions increased use of information and communication technologies (ICT) in relation to the public administrative functions of the building. We would be more concerned about how the project brings the benefits of ICT use to the community, rather than the town council.
- 9. The main aspect of the project appears to be refurbishment of the main hall with new windows and improved acoustics and lighting. We need to be assured that none of this work could be described as maintenance.
- 10. We recommend considering other avenues of funding to improve the accessibility of the building.

I am sorry that this letter is on a negative note. However, I think that your Members need to be made aware that the project faces considerable obstacles.

Pembrokeshire Residents Opinion Survey 2002

The survey, carried out by Beaufort Research, took place in the period February - April 2002.

The aim of the survey was to identify residents opinions on a number of issues relating to life in the County, with information gathered being used to prepare a Community Plan for Pembrokeshire.

Questions asked were far too many and varied to be detailed in this report, what I have attempted to do is bring out those areas which are topical with our Town Council at this time.

The outcome showed that although the majority of people had moved here less than twenty years ago, they enjoyed the area because of the 'friendly' and 'good' local people, added to this a great many said they felt safe living in Pembrokeshire.

By far the greatest majority were well satisfied with the large and varied range of opportunities to learn, while a fair majority say they are getting a good service from their doctor, with only 10% saying they are unhappy with the service at Withybush Hospital.

Of course, like all communities the respondents put forward a number of areas which could benefit from improvement.

When replying to the question of children/young people's facilities: 78% thought this was a big problem. While a further 57% saw it as a problem and 20% a small problem. On the same issue, 56% thought the existing play areas were within easy reach. This particular area is one which this Town Council have been aware for some considerable time, in particular the condition of, and up grading of existing play areas.

By far the biggest concern for the county, and more specifically our town, is the problem of litter, fly tipping and dog fouling. The above are just a few of the problems recognised throughout the Counties 161 Wards, while many of the other problems rest mainly with those living in the rural areas.

Planning Justice in Wales

I am writing to invite you to join Friends of the Earth Cymru's Campaign for Planning Justice. As you may know, the National Assembly is currently discussing changes to the planning system in Wales. This is a good opportunity to make the planning process in Wales fairer and more responsive to the needs and interests of local communities.

There are areas in which the planning system, as it operates currently, is unfair on the people it is supposed serve. For example, prospective developers in Wales have the right to appeal within the planning system against the rejection of their planning applications. Anyone else with an interest in such applications (so-called 'third parties'), including those who may be most directly and adversely affected by them, do not have an equivalent right to appeal when such applications are approved, except through the courts.

This glaring inequity leaves local communities without a fair opportunity to challenge either the need for or the merits of particular developments. Friends of the Earth Cymru hopes to persuade the Assembly Government to redress this imbalance so that local communities have the same rights and opportunities to shape development as developers currently have. But we need your help. The National Assembly's recent consultation document on planning declares that it does 'not envisage the need to introduce a third party right of appeal'. This is particularly disappointing news for Community Councils, since it limits their power to appeal (as 'third parties') against planning decisions in the interests of their communities.

I hope that your council will join us in our campaign for a fairer planning system in Wales. I enclose a copy of Friends of the Earth Cymru's briefing paper on this issue, which makes the case for a limited third party right of appeal against grants of planning permission by local planning authorities. A helpful first step would be for the council to pass a resolution in support of this policy. The more councils that do so, the more likely the Government will be to adopt a fairer planning policy. We would also encourage you to write directly to Sue Essex, the Minister for Environment, in support of a third party right of appeal in planning.

We would like to keep you informed about our campaign and hope that you will let us know about any steps that you take in support of third party rights in Wales. 

PEMBROKE MALTA

I refer to our telephone conversation regarding an application by the group known as Pembroke Sporting Link (see enclosed letter), who have applied for funding from the joint twinning committee of Pembroke Dock and Pembroke. They are travelling to Malta on 8th April 2003 for seven days with 23 children and 20 adults at a total cost of £10793 (£251 per person).

As you may or may not be aware, we are travelling to Pembroke, Malta on 08.04.05 for seven days.

The group will consist of 20 adults and 23 children (aged either 14 or 15). All of the group are living in either Pembroke or Pembroke Dock areas and attend Year 10 of Pembroke School.

The aim of the excursion to Malta is to develop the sporting, cultural and personal/social skills between the 'Pembroke's'. We are in close contact with Mr. Joe Zammit who is preparing an itinerary for the week. In this it is hoped that there will be an opportunity to participate in the following activities:-

- Promote sport football, rugby, cricket, basket ball etc.
- Environmental project is geographical location, climate, erosion of coast line which are all being studied in the national school curriculum at Pembroke School – water purification.
- To establish and participate in a community venture that may possibly be continued by other groups in the future.

The total cost of this venture is £10,793.00, which equates to £251,00 per person. This amount includes flights, half board accommodation and transport to/from Gatwick. Every person so far has paid the deposit amount of £110.00. This leaves a balance of £6,063.00. It is hoped that through various fundraising activities we can substantially reduce the remaining costs for the children, as for many this may be their only overseas venture.

We have arranged several forthcoming fundraising activities including:

Sports Quiz on 29.11.02 Sponsored Boxing Day Swim on 2612.02 New Years Party on 31.12.02 – to name just a few,

We are led to believe that should there be any European funding available, and secured, payment would not be received until after the event in April 2003. We must therefore work on the assumption that this may not be granted, and that all costs must be made by the members of the group. In this light, we would very much appreciate any form of sponsorship that either you as a twinning committee or as two town councils may be in a position to contribute, therefor reducing the costs for the children.
