The meeting was opened with Prayer.

28. APOLOGIES FOR ABSENCE

Apologies for absence were received from Councillors Mrs. P.E.M. Folland, Mrs. P.E.George, Mrs. J.M. Rees, and S. Perkins.

29. MINUTES

PROPOSED by Councillor D.T. Esmond SECONDED by Councillor P. Weatherall

RESOLVED –

That the Minutes of the last meeting of the Council held on 12th May 2005 be adopted as circulated.

30. MATTERS ARISING FROM THE MINUTES

(a) Minute 18 – Experimental Traffic Order – Dimond Street

Councillor Weatherall stated that two of the signs, as agreed at the on-site meeting, are still not in place. The two signs that are missing were to be sited at the entrance to Queen Street.

(b) Minute 25 – Planning Applications – 04/1585/PA

The Town Clerk reported that he had received a letter from Pembrokeshire County Council regarding application number 04/1585/PA, Central Garage Site, Pembroke Dock, in which they stated that no further action would be taken on this matter.

(c) Minute 25 – Planning Applications – 05/0057/PA

The Town Clerk reported that he had received a telephone call from Mrs. Lloyd who was very concerned about the potential loss of the footpath, should this application be approved. She uses a mobility scooter and would have problems if the path was not retained, as she cannot use the street.

Councillor D.T. Esmond also stated that many people use this path.

It was resolved that this information be forwarded to the Planning Department at County Hall.

32. MINUTES OF THE TOURISM COMMITTEE

RESOLVED -

The Mayor, Councillor R.G. Watts, advised that Mr. C. Morris, Chairman of the Chamber of Trade, Pembroke Dock, had resigned from the Tourism Committee. The Committee felt that this had been a sad loss as Mr. Morris had been involved with many of the arrangements for the forthcoming Summer Festival and had left before these were completed.

The Town Clerk reported that the Festival publicity had been received, and that 10,000 leaflets had been sent to the Western Telegraph and they would be distributed next Wednesday. The remaining 10,000 leaflets together with posters would be distributed within the next two weeks.

It was not certain that the Victorian Street Market would go ahead but support was being sought and encouraged. An article had been placed in the Western Telegraph which had attracted a couple of replies and the situation would be reviewed early next week.

33. REPORT OF THE TOWN CLERK

30. Visit to Malta – Pembroke Dock Harlequins R.F.C.

At a meeting on May 19th 2005, the Pembroke Dock and Pembroke Joint Tourism and Twinning Committee considered a request from Pembroke Dock Harlequins R.F.C. for a donation to assist with the costs of organising a visit to Malta in April/May 2006. Provisional arrangements had been made for a party of 60, including a Senior and Youth side.

The Committee recommended that a sum of £1000 be donated from each Town Council.

The Budget estimates for 2005/6 included a provision of £1000 for twinning purposes. In the 2004/5 estimates a provision of £2000 was not spent.

A copy of the letter, which was considered by the Committee was enclosed at Appendix 'A'.

Members' confirmation of the grant of £1000 was requested.

The Town Clerk reported that he had received a request that if the donation were approved, the cheque could be released the following day. Approval for the early release of the cheque was given.

31. Footpath, Treowen Road – Bufferland Terrace

At the last Council meeting the Town Clerk was asked to find out what progress had been made with the Council's request that this footpath be adopted and become a public right of way.

The Town Clerk enclosed at Appendix 'B' a reply from the Rights of Way Improvement Officer together with correspondence from Pembrokeshire County Council to the adjoining developer's solicitor.

Councillor Mrs. C. Fortune was very concerned that this had still not been resolved and requested that the Town Clerk write to Pembrokeshire County Council asking for the new appointee to the post to look at this as a matter of urgency.

33. Visits by H.M. Warships and Royal Fleet Auxiliaries

The Honorary Naval Liaison Officer, Commander Tony Mason had written to request whether the Council wished to be considered for a ship visit in 2006.

Requests would be considered in July 2005. A copy of Commander Mason's letter was at Appendix 'D'.

The Town Clerk asked for Members' assistance in completing the form.

Councillor P.G. Gwyther agreed to assist with the completion of the form.

Councillor K. Higgs asked for a concern regarding the footpath in Pembroke Ferry to be noted. The footpath had been re-instated following the installation of lighting, but had been put back without the tarmac being replaced. This would be drawn to the County Council's attention when the reply was prepared.

35. One Voice Wales

An invitation had been received to a presentation about the future of Town and Community Councils in Wales and the role of One Voice Wales in the modernisation process. The presentation would be held on Thursday 7th July 2005 at the Withybush Conference Centre, Haverfordwest, commencing at 9.30am. The invitation was for the Mayor and up to three other members. A copy of the programme was enclosed at Appendix 'F'.

The Mayor, Councillor R.G. Watts, said that he would be attending the presentation.
