**83. PRESENTATION GIVEN BY PEMBROKE DOCK SUMMER FESTIVAL COMMITTEE**

Members of the Committee who organised the Pembroke Dock Summer Festival in June made a presentation to the Council. They believed the week of festivities went well and would like to repeat the event in 2007 but expanding on the types of event organised.

The Town Council thanked the Committee including Communities First for all the work which had gone into the event.

**84. APOLOGIES FOR ABSENCE**

Apologies for absence were received from Councillors Mrs. P. Folland, P. Gwyther, K. Higgs, Mrs. J.M. Rees, and R.G. Watts.

**85. MINUTES**

**86. MATTERS ARISING FROM THE MINUTES**

**(a) Minute 154 – Warrior Tank etc. near to the Warrior Way Car Park**

The Town Clerk advised that he was still awaiting a response to his letter to the Army. He had spoken to Col. Rogers' secretary who had advised that they were sending someone to assess it and would then reply to him.

**(b) Minute 162 – Planning Applications**

**06/0684/PA – Land at 26 Nelson Street – Erection of 6 Starter Homes**

The Town Clerk had received a response from Mr. David Lawrence regarding the definition of the term “Starter Homes” which was attached as Appendix C. He had replied that this term was not defined anywhere in planning legislation, and that the use of the term was not critical but it was important that the designs for the particular location were acceptable. Members subsequently considered this application within the Town Clerk’s Report under the heading of Planning Applications.

**(c) Minute 171 – Parks for People Grant Scheme run by the Heritage Lottery Fund**

The Town Clerk had sent a letter agreeing to the suggestions made by Pembrokeshire County Council in setting up a committee to look at this issue. Councillor S. Perkins had spoken to Sinead Heneghan the previous day who had requested some members of the Town Council to be part of a committee that would work for the renewal/restoration of the Park. Councillor Perkins invited anyone who was interested in being a member of this committee to let her know. Councillors P.E. George and P. Weatherall both indicated their interest and also suggested that Councillor R. Watts who was absent should also be a member of this committee. The committee would then write to people/organisations who had an interest in the regeneration of the Park and ask if they would like to nominate a representative on the committee. At the same time Pembrokeshire County Council would hold a ‘brainstorming’ session, which would ask for ideas of what people wanted in the Park. Councillor S. Perkins agreed to arrange a date for the meeting and to notify the three interested members.

**(d) Minute 169 - Promotion of Rail Services on Pembroke Dock Line and state of Pembroke Dock Station**

The Town Clerk advised that Mr. Youngman would be attending the Town Council meeting on 14<sup>th</sup> December 2006.

**(e) Minute 172 – Consultation on Gambling Policy**

This item had been deferred from the Town Council Meeting of 5<sup>th</sup> October. No further comments were made by members and the Town Clerk advised that he would reply to the County Council indicating that the Town Council were satisfied with this document.

**(f) Minute 173 – Pembroke Dock Winter Carnival**

Councillor Mrs. P.E. George advised that the Town Clerk had letters to distribute the following day to local businesses and organisations, and that she had also spoken to Communities First asking for their support.

## **87. REPORT OF THE TOWN CLERK**

### **179. Consultation on Gambling Policy.**

At the Town Council meeting held on 7<sup>th</sup> September it was decided that this matter should be deferred to the meeting to enable Councillors to study the proposed Gambling Policy Licensing Statement issued by the County Council.

This matter had been dealt with under Matters Arising from the Minutes (Minute 86(e)), i.e. the Town Clerk had agreed to respond to Pembrokeshire County Council indicating that the Town Council were satisfied with this document.

### **180. Consultation on draft guidance on the Clean Neighbourhood and Environment Act 2005.**

Copies of the guidance had been received from the Welsh Assembly Government and were enclosed. Responses to the questions posed were requested by no later than 29<sup>th</sup> December 2006. The Town Clerk suggested that Members might wish to comment on each item then or defer it until the November meeting to consult with their ward constituents.

Members agreed that this matter should be deferred until the next Town Council Meeting in November.

### **181(a) Request from Pembroke Dock Chamber of Trade and Commerce.**

#### **Membership of the Tourism Committee.**

The Town Clerk had been asked by the Pembroke Dock Chamber of Trade if they could be represented on the Tourism Committee as had been the practice in the past. This had already been agreed by the Tourism Committee and was endorsed by the full Council.

#### **Representative of Town Council to serve on the Chamber of Trade Committee.**

In addition they had asked if the Town Council would like to nominate a member to serve on their Committee. Councillor D. Esmond stated that he was willing to act as a representative of the Town Council as he was eligible to join the Chamber of Trade. In addition the Town Clerk had been asked to attend occasional meetings to update the Chamber with details of actions / initiatives being taken by the Town Council etc.

### **181(b) Off Street Places Variation Order 2006/4.**

The Town Clerk had been sent by the County Council a copy of the proposed charges to be imposed in respect of two places within Pembroke Dock viz. Gordon Street Car Park and Lower Meyrick Street. Copies of the correspondence together with the statement containing the County Council's reasons for making the order were enclosed at Appendix A.

Any written observations the Town Council wished to make on the matter had to be with the County Council by 30 November 2006.

Councillor S. Perkins commented that she was concerned that the people of Pembroke Dock did not fully realise the impact that these charges would have. Bush and Park Residents Association were distributing petitions, and she asked if Town Councillors could also help with this. She suggested that people could distribute posters and leaflets, and also send individual letters to Brian Hall, the Cabinet Member for Transportation. She advised that Councillor Kate Becton had already sent a letter to the County Council asking for details of the Pembroke Dock assessment and whether this took account of the fragility of the economy of the town.

Councillor Kate Becton was happy to support petitions and letters. She had replied to the County Council specifying her particular concerns.

Councillor Perkins confirmed that she would get the flyers/petitions printed the following day which would be with the Town Council on Monday.

The Town Clerk suggested that Jeremy could distribute leaflets to households in Pembroke Dock which would take 2 days at an approximate cost of £120. Councillor Mrs. C. Fortune suggested that it might be preferable to leaflet the cars in the ASDA Car Park and have a petition in the ASDA store, to which members agreed.

It was also agreed that Councillors would be given copies of petition forms which they could distribute in their ward, that someone should stand outside ASDA with petition forms, and that the Chamber of Trade would be asked to participate.

Councillor D. Esmond commented that Pembroke Dock was the only place that did not have an all day rate for parking, and suggested that the Town Council should write to the Welsh Office and ask why Pembroke Dock was being treated differently to other areas.

If a satisfactory reply was not received then the matter would be referred to the Welsh Assembly Government to see if they could intervene.

**182. Save Withybush Hospital Action Team – Charity Ball to be held on Friday 17<sup>th</sup> November 2006 at the Cleddau Bridge Hotel .**

The Town Clerk had received a letter and enclosures (Appendix B) from the Secretary of the group who were organising a fund raising event.

Members who wished to attend were asked to complete the reservation form provided.

### **183. Pennar and Bufferland Community Association.**

Councillor Mrs. C. Fortune and E. Hissey declared their interest in this matter.

The Town Clerk had received a letter from the Association asking if the Town Council would support an application to install a CCTV Camera close to the St. Patrick's Childrens Play Area. It was suggested that such a camera would reduce vandalism in the area surrounding i.e. St Patrick's Church, the Community Hall, Treowen Road and Military Road as well as the Play area itself.

Members' opinions on such a request were sought.

Councillor Mrs. Fortune advised that there had been an increased occurrence of near-accidents on the junction of Ferry Road/Treowen Road, and there had been a build-up of youths, vandalism and speeding cars in the area near the Community Hall and Youth Club. A meeting had taken place where it had been suggested that a camera might calm traffic down, and be a deterrent to vandalism and graffiti.

Councillor Mrs. Fortune stated that she was requesting the Town Council's support in any application they should make, to which members agreed.

### **184. Requests for Financial Assistance.**

The Town Clerk reminded members that the Town Council's eligibility criteria for the awards of grants was clearly set out in the application forms which were issued to each organisation. No longer was there a need for the organisation to have a base within the town. The broad criteria read as follows:-

"The Town Council, within the limitation of the resources available, wish to support charities or not-for-profit organisations who are engaged in helping those who live within the Town Council area. The Council will therefore consider offering grant aid to those bodies which meet the following criteria:-

1. The services, facilities or activities for which grant aid is sought are wholly or mainly benefiting the residents of Pembroke Dock.
2. There is a need in Pembroke Dock for the specific services, facilities or activities provided by the organisation.
3. The organisation is a registered charity or "not for profit" body.
4. The organisation has financial need which will be assisted by the grant sought or without which the services, facilities or activities could not be provided or provided at a much reduced level.
5. Other sources of funding have been fully investigated and where possible secured.
6. The organisation actively encourages disadvantaged groups in the community to make use of the services, facilities or activities provided.

The Town Council had set the following priorities for 2006/7:-

Support for Older People – Support for voluntary organisations working with the elderly

Children and Young People – Investing in young people and those organisations working with young people to provide skills and recreational opportunities

Safer and Stronger Communities – Support for initiatives to improve the town environment

The Town Clerk had received the following applications for grant aid:-

**(a) Urdd Gobaith Cymru.**

The application request was for financial assistance towards the running costs of the charity. The Urdd organises 9 Eisteddfods and 32 competitions each year in the County with over 1500 of the County's members attending courses and fun weekends at the Urdd Centres at Llangranog and Glanllyn. The cost of maintaining staff and an office within each County was £47,000 per annum. The number of children involved as members of the Urdd within Pembroke Dock by school was as follows:-

St. Mary's Catholic School	- 25 members
Pembroke Dock CP School	- 48 members
Pennar CP School	- 46 members
Pembroke Comprehensive School	- 37 members

The Town Clerk reported that one event had been held at the Pater Hall in the past 6 months.

**(b) Cleddau FM.**

The above organisation had applied for grant aid towards the cost of running the station. The organisation is a community based radio station covering the areas of Pembroke, Pembroke Dock and Neyland. They also stated that a grant from the Town Council would assist them in their aims of "bringing the community to the community through the radio medium. The Town Clerk had been told that the cost of renting equipment etc for a 28 day broadcast period was £3,936.25 which was being met from donations, sponsorship and advertising. The organisation was not currently a charity but they would be applying for such status. Their accounts showed that at the end of the year 2005/6 the organisation had a credit balance of £2463.73

**(c) Friends of South Pembrokeshire Hospital.**

The above organisation which is a registered charity had applied for grant aid stating that their principle aims and objectives was to create awareness and inform the public about the needs of patients / clients at the hospital and people in the community. At 31 March 2006 their credit balance was £12527.69.

The aim of the group was to provide entertainment for their members through the provision of speakers at their meetings, occasional coach tours and group meals such as Christmas. At the end of their last financial year their credit balance was £1481.

## **88. SUPPLEMENTARY REPORT OF THE TOWN CLERK**

### **187. Provision Of Christmas Trees In The Town.**

Members were requested to confirm that two Christmas Trees be purchased this year for display in the town. One would be located in Lower Meyrick Street near to the St. Govans Centre and one would be located at the Pump House. The cost this year would be £87 for the one at the Pump House and £141 for the one near the St. Govans Centre making a total cost of £228.00. It was hoped that the lights on the trees and other Christmas Decorations within the town would be ready to be switched on by 27<sup>th</sup> November. The Christmas Lights will be erected over the weekend of 25<sup>th</sup> /26<sup>th</sup> November. In addition Council might wish for a small artificial Christmas Tree to be placed in the foyer of the Pater Hall or on the balcony.

Members agreed to these arrangements for the purchase of Christmas Trees and that a fibre optic tree be placed on the stairs of the Pater Hall.

## **188. Letter From Emma Clarkson**

Emma is a Cadet Warrant Officer with the 1574 Squadron of the Air Training Corps. She had applied for financial assistance to help her take part in the International Air Cadet Exchange which was held in the USA in July 2006. The Town Clerk had received a letter of thanks from Emma together with a copy of the presentation she made on her return to this country. The copy was on the side table for members to view. If necessary the Town Clerk had the Computer Disc of the photographs etc which could be borrowed by members.

### **(a) Shelter Cymru**

The Town Clerk had received an application for financial assistance from the above organisation which was looking for a contribution towards the cost of providing free advice to those seeking advice on housing issues. In the application they stated that they provided 5 advice surgeries within the Pembroke Area and last year dealt with 227 people at these centres. As at 30 September 2005 they had £11,382 in general unrestricted funds with a further £472,001 in designated funds.

## **90. SIX MONTH BUDGET REPORT**

A copy of the six month Budget Report had been distributed to members at the meeting. The Town Clerk asked members to note that the Town Council would receive a grant from the Townscape Heritage Initiative of £5,305 towards the cost of the finger posts, the cost of which had been shown in full under item 5(f). Item 6(g) was a grant of 80% of wage and salary costs of staff carrying out duties for the Pater Hall Community Trust. Item 8(a) – it was likely that costs for the Winter Carnival would be in the region of £2,200 to include fireworks prizes and publicity, etc.

The balance in the various accounts at 30 September were:

Pater Hall Improvements Account	£36,331.36

The final precept payment of £36,290 would be received in December 2006. The Town Clerk suggested that the Pater Hall Improvements Account be closed and the balance placed in the Deposit Account. The Town Council had agreed in principle to give a grant of £30,000 to the Pater Hall Community Trust in the 2006/7 financial year.
