109. Funding applications

Pembrokeshire Special Needs Gym Club

The Town Clerk stated an application for funding had been received from the above organisation requesting funding of £200. The fund will be to help gymnasts who are competing in the Special Olympics which are being held in Sheffield. There are 35 people currently benefiting from this service with 4 from Pembroke Dock, and one person from Pembroke Dock attending the Special Olympics.

Winston Churchill Memorial Trust

An application for funding had been received from the above organisation. The organisation is based in Pembroke Dock and is a registered charity.

The fellowship provides a unique opportunity for British Citizens to travel overseas to bring back fresh ideas and solutions to today's issues for the benefit of others in the UK. The Town Clerk had included within Members' papers a copy of the grant form for further information, and stated that the contact for the group George Parfitt had requested funding of £450.

Members discussed this application and all agreed to the suggestion made by Councillor Gwyther, to ask for a presentation from the group at the next Full Council Meeting before any decision was made.

110. One Voice Wales Membership

Pembroke Dock Town Council had been contacted by One Voice Wales to ask if they would like to become a member of One Voice Wales at a 50% reduction of the yearly fee. The normal fee for One Voice Wales is £1332 but they are offering the membership for £666 for the first year.

The Town Clerk stated that:-
