## 40. Friends of Memorial Park Financial Report 22/23

The Town Clerk stated that she had attached the documents for members to review, as the Town Council supplied this group with funding through a Service Level Agreement. She said that this financial update has been provided to give a clear guide of funds received and how they have been spent. The Town Clerk stated that as you can see the group are struggling for active volunteers, and asked if they know of anyone that may be interested to contact her or the Chairman Joshua Beynon. Cllr Briskham expressed an interest in volunteering on the Friends of Memorial Park Group.

#### 41. Grant Application - Pembroke Dock Men's Shed

The Town Clerk informed members that she had attached the revised application from the Pembroke Dock Mens Shed. She said that she is aware that the application should go to the Finance Committee first but as a meeting with the finance is not due soon she felt that Full Council should review the application in the meantime.

The Town Clerk stated that the group are looking for an amount of £900.00 to assist with the running costs and development of new activities. She said that the Mens Shed are now also offering a warm social area for members to socialise over a cup of tea and biscuit in a safe and friendly environment.

Cllr O'Connor commented that it is clear from our website when applications will be considered and proposed that this application should be sent to the Finance Committee to make recommendations.

Cllr Manning commented that he can see where Cllr O'Connor is coming from, but said that if there was money left in the donations pot as it is coming to end of year he proposed that members consider the application this evening.

The Town Clerk stated that there is enough money to cover the application as there has not been many applications during the financial year.

It was PROPOSED by Cllr Manning SECONDED by Cllr Goff RESOLVED That – members of PDTC agreed to review and consider the grant application during the current Full Council meeting. Cllr Lyons commented that the Men's Shed do charge members individual membership fees at a cost of £15.00 a month. He said that they did want money for the kitchen but nothing was ever done with the kitchen, and they have since had to leave the building and moved to the VC gallery.

Cllr O'Connor commented that he is concerned that if they didn't spend the money on the kitchen they never returned the money. Also charging monthly memberships is detrimental to the poorest and most need of help. He said that they are not inclusive organisation.
